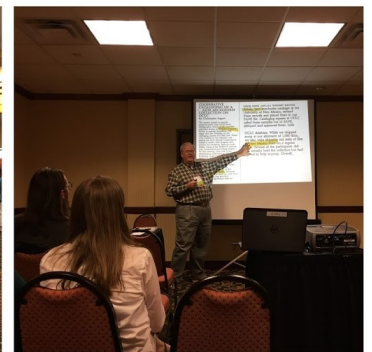

## Library Supports Access to Justice

The New Mexico Supreme Court Law Library joined the Volunteer Attorney Program, the First Judicial District's Access to Justice Committee, New Mexico Legal Aid, and the NM Motor Vehicle Department to work at the Santa Fe Legal Fair on Saturday, October 20, 2018 at the Genoveva Chavez Community Center. Lawyers helped 77 people free of charge with legal issues such as wills, advance health care directives, power of attorney forms, and other non-criminal topics. ## Voters Pass Bond B in Bernalillo and Sandoval County Library Bonds

Library bond issues were successful statewide in the 2018 New Mexico General Election. State General Obligation Bond B, providing \$12.876 million for public, academic, public school and tribal libraries passed by an unofficial margin of 231,310 votes. With 424,619 yes votes and 193,309 no votes, Bond B won with 68.72% in favor, 3.9 percentage points higher than attained by library bond issue B in 2016. This progress was accomplished through higher margins in all but nine counties, with the greatest margin gains in Grant, Santa Fe, Mora, Harding, Quay and Bernalillo Counties. Only two counties, Catron and Union, rejected the measure. Taos County was once again the banner county for support at 81% yes, followed by Santa Fe at 77.3% and McKinley at 73.4%.

Bond B showed the second highest level of support among the four state bond issues; the \$10.77 million senior citizen facilities Bond A received 70.8%, with library bond (B) at 68.7%. A new category on the ballot is Bond C, providing \$6 million for school busses, which received a 68.8% yes vote. Bond D, providing \$136 million for higher education facilities, passed with a 65.7% yes vote. These are unofficial complete totals, which will be updated when the State Canvassing Board meets later this month.

In Bernalillo County, library bonds providing \$1.75 million to the Public Library Albuquerque and Bernalillo County passed by a vote of 160,977 yes to 56,294 no, a 74.1% margin. This margin is more than the 2017 City of Albuquerque library bond margin of 71.7% and slightly below the 74.4% margin for the 2016 County library bond. Voters in Albuquerque and Bernalillo County have now passed sixty-two consecutive library funding questions dating back to 1892, with an average margin of 69.0% favorable, and totaling \$140.4 million in funding. The drop-off in support in Bernalillo County between the County Library Bond and State Bond B is 1.8%. The Bernalillo County library bond was fourth highest in voter support among the six bond issues proposed to county voters in 2018.

In Sandoval County, voters passed Bond Question 1 providing \$3,385,000 to 15 public and tribal libraries by a vote of 35,220 in favor and 18,305 against, for an approval rate of 65.8%. The margin of victory increased by 6.3% over the 2014 Sandoval County Library Bond Issue, which had passed by a 59.5% margin. The county library bond also ranked highest for Sandoval County among the three county bond issues proposed in 2018.

The library community was mobilized to support Bond B through the activities of the Bonds for Libraries Special Interest Group (SIG). Under the chairmanship of Omar Durant, the SIG promoted the legislation, raised funds, prepared campaign materials and placed advertising. The SIG website provided local library supporters with a variety of media to promote passage of Bond B. Linda O'Connell worked with Robyn Gleasner to replace the SIG website on a new platform; [nmbondsforlibraires.org](http://nmbondsforlibraires.org). Chris Schipper and the New Mexico Library Foundation created a webpage charting prospective bond allocations for every library by county. A display ad was also placed on the state's leading political blog, "New Mexico Politics with Joe Monahan." Bond B was endorsed by the Albuquerque Journal and other newspapers around the state. The financial support of the Albuquerque Friends for the Library was especially appreciated.



Strengthen the Federal Depository Library Program

## Kathy Barco Wins MPLA Distinguished Service Award

MPLA Distinguished Service Award: To be given to an MPLA member who has made notable contributions to the library profession, furthered significant development of libraries in the Mountain Plains region, or performed exemplary service for an extended period of time.

Awarded at the 2019 MPLA Conference, Wichita KS

From Val's nomination:

Kathy Barco is currently a library consultant and book author. Kathy has been a library advocate for children and reading her entire career. One of her favorite reading philosophies is from Ranganathan's Five Laws of Library Science, "For every book a reader, for every reader a book." Kathy has spent her library career making sure that children find themselves in books. Kathy started her library career working as a Children's Programs Coordinator at the Andersen Air Force Base Library in Guam. She moved back to her home state of New Mexico and worked in various roles with books and children for the Albuquerque/Bernalillo County Library System. She also worked as the Youth Services Coordinator for the New Mexico State Library where she served children and youth librarians from all over the state of New Mexico.



Kathy's professional life has not slowed down since her retirement from the Albuquerque/Bernalillo Library System. She has continued to work as a library consultant on various projects including providing consulting services to librarians as they plan summer reading programs in Kansas. She recently co-authored a book with Melanie Borski Howard called *Storytime and Beyond - Having Fun with Early Literacy* (Libraries Unlimited 2018). Kathy attends ALA's Midwinter and Annual conferences almost every year. One of her strengths as a conference attendee is her tenacious ability to comb the vendor hall for new ideas that she can share with teachers, librarians, colleagues, and friends.

As Kathy's nominator I can speak most specifically about Kathy's career as a Youth Service Coordinator at the New Mexico State Library. As a coordinator, Kathy worked with her friend and artist Mike Jaynes to invent the summer reading program for New Mexico's libraries each year. The summer reading planning was a year-long project in which they came up with a theme, developed characters, and created activities for children and teens. Their New Mexico-specific summer reading programs included *Once Upon a Planet*, *READiculous!*, and *READiscover New Mexico*. Both Kathy and Mike took each of their summer reading programs "on the road" as they provided training and creative inspiration to librarians as they prepared to launch summer reading programs in their communities. The unique programs they developed and marketed were used by hundreds of librarians and created learning and creative opportunities for thousands of children in New Mexico.

As a colleague with Kathy at the New Mexico State Library, I know children's librarians depended on her. They called her to get consulting advice on a wide range of subjects. Kathy was always kind, professional, patient, and prepared to take action. One noteworthy example of this was when the State Library's consulting office was contacted about conducting an intellectual freedom workshop for library staff in New Mexico's four corners region. At the time the request came into the office, the organization was severely under staffed with only three consultants. No one on the staff had the expertise to do an intellectual freedom workshop. Instead of saying "no" to the request, Kathy said she would think about it. As she thought about it she developed a structure that included performing book talks as creative inspiration for the librarians. While everyone had fun talking about books the presentation also had sections that included important intellectual freedom information. Something that would have been an easy "no" at the time turned into a "yes" and has inspired more than 40 intellectual freedom presentations and the book I co-edited with Kathy, *True Stories of Censorship Battles in America's Libraries*.

I know Kathy has supported and mentored at least two young New Mexico librarians

## Banned-Tastic Display

The Rio Rancho Public Library looks forward to Banned Books Week each year, where the librarians use their creativity to come up with different displays. This year Youth Services Librarian Jenny Gregg and Adult Services Librarian Kathy Campbell created a new and novel display.

Jenny envisioned a video featuring a variety of citizens reading from banned books in front of a police lineup background. She approached city councilors, Friends of the Library, public safety officers, journalists, students, and others. The result was a display with an 11-minute video, surrounded by actual challenged books and “flames.” Kathy designed an informative brochure to go along with the video, explaining why each of the 12 featured books had been challenged. The display was positioned near the entrance of the library, across from the circulation desk. The video was quite the attention getter among patrons. The circulation staff heard such comments as “I can’t believe the dictionary was banned!,” “Hop on Pop? Really?!” and “Look! There’s the Fire Chief!”

through library school and into their professional careers. Both people were librarians in rural New Mexico. Both have gone to library school, graduated, and are back in New Mexico severing as professional librarians in youth service fields.

Kathy has always been a supportive colleague to me personally (and I know she has mentored and supported many people in her professional journey). At an especially difficult point in my career when I was laid off from a library job I loved, Kathy applied for the two of us to speak at a children's book festival, set up our travel, and negotiated reduced rates for us to attend the conference. Her creativity and joy inspired me to stay in the field of librarianship and introduced me to the power and brilliance of children's writing and children's book authors.

In all of these examples, Kathy is a supporting cast member. She is not usually the star of her creation. She encourages others to teach, learn, be creative, and strive. Her mentoring, her inspiration, the books she writes, and the tools she creates are meant to inspire others to reach their goals.

## In Memorium: Carol Ann Myers

Carol Ann McClary Myers was born in Dawson, New Mexico on June 2, 1928. Carol grew up with her older brother, Robert McClary, and a younger sister, Marcia McClary. After graduating High School in Dawson, Carol attended the University of Redlands in California.

Carol met Dwight Myers when she was a senior and he was a freshman at Redlands. They married on September 16, 1950. Carol graduated with a Bachelor of Music degree in Education. She taught for two years at Barstow Junior High School as well as in the elementary schools of the little outlying communities of Daggett, Yermo, and Hinkley.

Dwight enlisted in the Air Force in 1952. He was then assigned to Lawson Air Force Base in Columbus, Georgia. There, Carol took a civil service job in the Armament Shop of Ft. Benning. Before being reassigned to Kirtland AFB in Albuquerque, Dwight and Carol had their first son, Robert Andrew, in Georgia. Debra Ann Myers & James Andrew Myers were then born in Albuquerque.

The family moved to New Jersey for ten years where Carol taught private piano lessons while raising three children. In 1970 the Myers' family moved back to Albuquerque. Soon after, Dwight and Carol started the New Mexico Book League and its magazine, *Book Talk*. Carol also began employment at the University of New Mexico Press in late 1973, and continued until her retirement in 1988. Carol was the Sales Manager at UNM Press. Dwight and Carol both came to retire in their beloved Albuquerque, NM.

In 1988, the New Mexico Library Association gave Dwight and Carol Myers their highest honor – Life Membership. They continued to be very involved in NMLA and its interests. Carol served as Treasurer for NMLA and Dwight served on the Board as Awards and Education Chair.

Carol passed away on July 31, 2017, and is survived by her eldest son, Robert, and his wife, Lorraine, of Albuquerque, NM; daughter, Debra Myers and partner, Ray Parrish of Alto, NM; and son, James, and his wife, Jennifer, of Albuquerque, NM; James' daughter, Brianna, and son, Taylor, of New York. Robert is owner of The Albuquerque International Rattlesnake Museum of Old Town, Albuquerque. Debra is now Assistant Director and Children's Librarian of the Capitan Public Library. James is Director of Business Development at OnPointe Senior Care, Albuquerque.

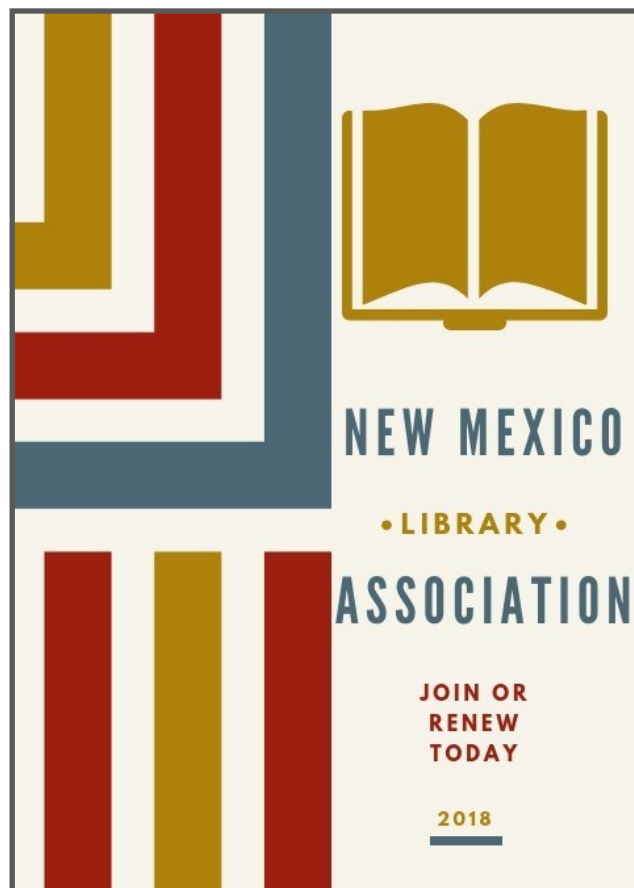
